

SPEEDY 1800 embarked 53 women.

I decided to try to find documented evidence from available sources to isolate out who might have been Josephus's mother. It is just research as we will never know and many family believe it to be Sarah Basden. I also had a look at documents relating to Sarah Basden in another research piece which I am still working on.

If Josephus is listed in Anna King's diary as about 7 months then he is likely to be born early 1799 putting the pregnancy around late 1798.

BY PROCES OF ELIMINATION THE ONLY WOMEN WHO COULD POSSIBLY BE THE ONES REFERENCED IN ANNA KING'S DIARY AS DYING AND LEAVING A 7 MONTH OLD BABY ARE:

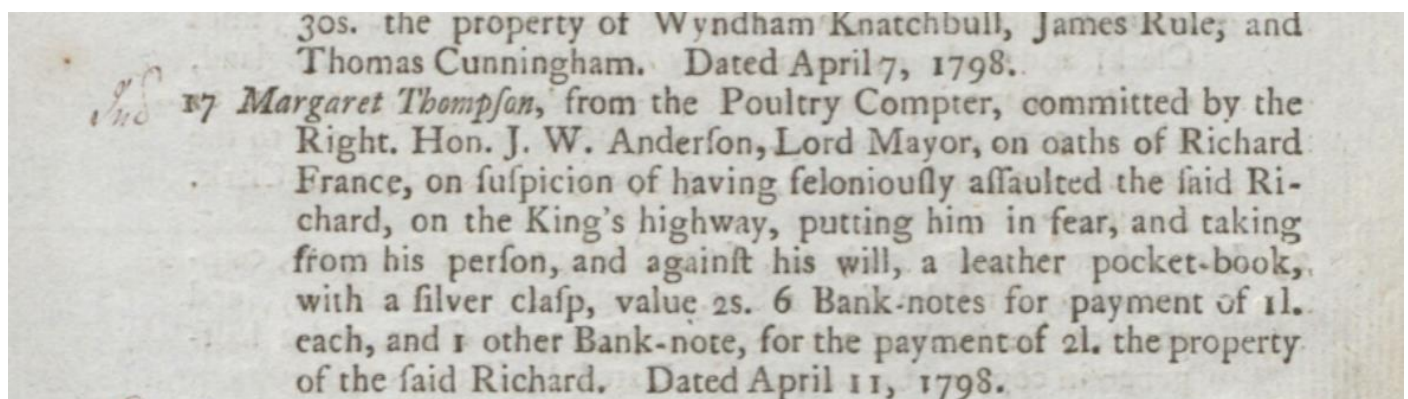
- Elizabeth Falkner- convicted at Guildford Surrey- possible death record in 1803
- Margaret Thompson- no early colonial records can be found.
- Sarah Clark-possible death record in 1802.

Only 1 of these 3 women died on board as we know Anna King's diary proves Mary Butler and Elizabeth Statham plus JHB's mother unnamed in the diary were the 3 women who died. Mr Wise who also died was counted separately. Several young children also died on the voyage and are unnamed except Jane Paterson's child.

There had been one other woman who was a contender but with weight of evidence she was removed from consideration:

- Mary aka Catherine FitzJohn

The most probable mother in my opinion is Margaret Thompson aged 33 yrs in 1798/99 and looking at her Old Bailey trial she could well have been stitched up for this crime or she may have been an experienced criminal or single and in her thirties a poor woman trying to get by . She is cited as Mrs Appleby in the record of trial and it looks as if there had been 2 previous hearings one in Guildhall and one by Lord Mayor (below) on this crime. The address where the crime was committed is Cheapside and cnr Bread St London. Poultry Compter (also known as Poultry Counter) was a small prison that stood at Poultry, part of Cheapside in the City of London. The compter was used to lock up minor criminals and prisoners convicted under civil law and was run by the City's Sheriff. Her file however states that the defendant did not plead pregnancy as reason for appeal on 25th May 1798. Could this indicate she was pregnant and chose not to use this in the trial or that she was not pregnant at this stage. There is also some evidence that a Margaret Thompson aged 32 in 1797 was imprisoned in 1797 and tried on 26th April 1797 found guilty and sentenced to whipping. She was privately whipped and discharged. This looks like the same Margaret. This Margaret was a mantua maker according to the 1797 trial. This looks like she was a skilled seamstress. These records describe Margaret as 32 5/6 Fair complex. brown hair. hazel eyes Edinburgh Single. Indicating she was born in Scotland. There are too many Margaret Thompson/Thomson's born in the years 1766-

1768 to identify her. Convict indents for Speedy list Margaret as born in 1767 and being aged 33 in the year of her conviction.

Another family historian Tanya O'Neill however cites Sarah Basdon as the probable mother for the following reasons:

I don't think that Sarah Barsden was alive on arrival I can see how it looks like she is on this census but when you look deeper the woman listed isn't Sarah Barsden as that census is full of errors. Here is my reasoning:

1. The census lists Mary Ann Barsden and Daughter Margaret Jane Barsden as coming here on the Speedy both were not even born in 1800. See circled in red above it says all three of them are arriving here in 1800. So straight up this census has got 2 people who were born in the colony as being passengers on the Speedy both marked as arriving before they were even born. So errors 1 and 2.
2. It lists all three of them as on the Speedy we know Mary Ann and Margaret were not on the Speedy so errors 3 and 4.
3. Error 5 it says Sarah Barsden is married to James Bardsley of Parramatta. James Bardsley is married to Sarah Bardsley nee Grigg so the person who has transcribed Barsden has made another error. They got the husband's name right but not the wife's name. The person on this census document is Sarah Grigg born in the colony not Sarah Barsden this is the correct James Bardsley as on both documents he is listed as the ship Morley.
4. I believe Sarah Barsden is his mother and she did die on the voyage out here because this census document is wrong and that Sarah is Sarah Grigg.

The question remains for me that who was the Sarah Barsden reported incorrectly in one census as J Barsden's wife and then as J Bardsley's wife. The second J Bardsley is clearly a mistake but why create a woman in 1822 census called Sarah Barsden in the census if none existed? There are clearly mistakes in this one also as Sarah would not have been born in the colony and Mary Ann did not come via the Speedy.

Given this we will consider that there were 4 women who could have died as the 3rd convict and the two without adequate evidence to exclude are Sarah Basdon and Margaret Thompson. The story may well have come however from the FitzJohn story about a wife being innocent of her husband's doing.

Speedy Convicts:

- Mary Atkins**. Age 30. Tried in London 4 July 1798¹ and sentenced to 7 years transportation for feloniously stealing, on the 1st of June, a cotton gown, value 10s. the property of Thomas Davis. [Old Bailey Online](#). Confirmed she disembarked as she is in the 1814 and 1818 census.
- Sarah Baker**. Age 28. Tried in London 12 September 1798 and sentenced to 7 years transportation . arrived she is in 1818 census.
- Sarah Basdon**. Tried Sussex Q.S. 7 October 1796 and sentenced to 7 yrs transportation. Arrived as listed in census 1828 as wife of John Bardsley Parramatta but this can be questioned as she is listed as coming on Speedy but born in colony also. The 1822 census has her as wife of J Barsden of Parramatta coming on Speedy and born in colony. There is also a baptism at Parramatta for Joseph Barsden son of Joseph and Sarah Barsden in 1800 conducted by Samuel Marsden listing a birth date of Joseph as 16th June 1799. Was this done by the King's to give him an identity?? A look at 1811 and 1819 census for women named Sarah there is no listing for Sarah

Basdon/Barsden and there is a Sarah Wood who was tried in 1798 London. Sarah Basdon married a Wood in 1850's but it does not seem to be this Sarah Wood of the census.

4. **Margaret Battersby**. Age 33. Tried in London 24 October 1798 and sentenced to 7 years transportation for feloniously stealing, on the 22d of October, a base metal watch gilt with gold, value 2l. 5s. the property of Thomas Jones, in his dwelling-house. Prisoner's defence. I did not do it from any bad principle, but from distress. - [Old Bailey Online. Arrived and in 1817 list of convicts](#)
5. **Mary owmend**. Age 42. Tried Middlesex 9 January 1799. At the Old Bailey on 9th January 1799, Mary BOWMANA was indicted for feloniously stealing, on the 29th of December , a tin-saucepan, value 12d. and an iron frying-pan, value 12d. the property of Elizabeth Joshua . Her age was given as 52. Arrived in 1817 list of convicts. Also listed as Mary Bowmans and Mary Bowmena
6. **Elizabeth, alias Sarah Brown**. Age 27. Tried Middlesex 3rd April 1799 and sentenced to 7 yrs transportation for feloniously stealing, on the 22d of March , four guineas, the property of Edward Levi , privately from his person. Prisoner's defence. I met this man in Bow-street; he asked me if he could go home with me; I asked him what he would make me a present of; he said, four guineas; but whether he gave me the four guineas, or whether I took it, I cannot say, for I was very much intoxicated.. [Old Bailey Online- .](#) She arrived in Sydney
7. **Margaret Buckie**. Age 42. Tried Middlesex 12 September 1798 and sentenced to 7 yrs transportation for feloniously stealing, on the 10th of July , a cotton shawl, value 3d. two muslin aprons, value 7s. a linen shirt, value 3d. a tippet, value 1d. a laced cap, value 5s. a table cloth, value 2s. 6d. a pair of cotton stockings, value 2s. and two silk sashes, value 2s. the property of John Williams. Prisoner's defence. I had some work to do for her, and she gave me the shawl with the things wrapped up in it. - Old Bailey Online.. Have found her in census/muster documents listed as Margaret Bucker and there is a record of marriage:

8. **Martha Burrell + child 2 yrs old..** Age 22. Tried Surry Quarter Sessions 12 January 1796. Arrived in 1817 list of convicts.. In 1828 she is listed as aged 53 and in the employ of James Paget. She came out on Speedy. On the list of convicts sent by Speedy Martha is listed with a child. 1822 listed as wife of T Sharp ? Wins... possible Wisemans Ferry? They have 4 children born in the colony. Census and muster records have found James, William, John, Ann, Mary and Martha Burrell. 1825 she is a widow. William aged 16 is born in colony and son of Martha Mary aged 14 is listed as born in colony and dtr of Martha. There is also an Ann Burrell wife of John Burrell of Windsor and their children are James an infant and Mary and Ann who are 5 year old twins.
9. **Mary Butler**. Age 30. Tried Lent Assizes. Kingston upon Thames 21 March 1798 and sentenced to 7 yrs transportation, DIED ON SHIP

10. **Ann Chaddick**. Age 23. Tried at Reading on 3rd March 1798 and sentenced to transportation for life. Anne Chaddick became the wife of Edward Lovedy, soldier of the 102nd reg.,. Petition of Lovedy for confirmation of his wife's pardon to enable them to return to England dated 30 January 1810. She received an absolute pardon in march 1810- Arrived- absolute pardon documentation.
11. **Sarah Clark**. Age 30. Sarah Clark. Tried Summer Assizes, Guildford 30 July 1798 and sentenced to transportation for life . ONLY TRANSPORT DOCUMENTATION. There is a Maria Clark in 1811 census in Tasmania having come on Speedy. No other information is known but Maria Clarke is not on the indents.

Looking through FMP and Ancestry there are no other Sarah Clark's in the early 1800's which would match this woman. I am prepared to call this one and say the balance of evidence is that this is the Sarah Clark of the Speedy.

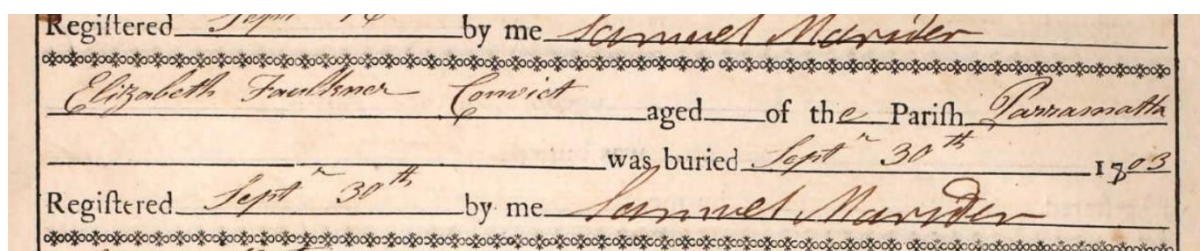
12. **Ann Clarke**. Age 28. Tried Middlesex 3 April 1799 and sentenced to 7 yrs transportation. ANN CLARKE and MARGARET RILEY were indicted, the first for feloniously stealing, on the 3d of April , a leather pocket-book, value 1s. 6d. a guinea, a half-guinea, and 9s. the property of William Downs ; and the other, for that she,

knowing Ann Clarke to have committed the said felony, her the said Ann, did feloniously receive, harbour, assist, and maintain . Arrived and in 1806 and 1811 census.

13. **Elizabeth Coleton**. Age 14. Tried in London 9 January 1799 and sentenced to 7 years transportation. Elizabeth Colton was indicted for feloniously stealing, on the 10th of January , two candlesticks, value 1s. a woollen jacket, value 5s. a woollen cloth coat, value 10s. 6d. two linen handkerchiefs, value 2s. 6d. a linen shirt, value 1s. and a yard of flannel, value 6d. the property of John Bouccock . [Old Bailey Online. Arrived and in 1811 Muster](#)
14. **Mary Evans** Age 29. Tried 4th July 1798 at Middlesex and sentenced to 7 rs transportation for feloniously stealing, on the 4th of July , a watch, the inside case made of metal, and the outside of tortoiseshell, value 3l. a steel watch-chain, value 6d. a cornelian stone seal set in base metal, value 6d. a brass watch-key, value 1d. and five guineas in money, the property of William Bond , in the dwelling-house of Jeremiah Day. Prisoner's defence. I was in Dyot-street between one and two o'clock, talking with two young woman, and he began to pull the girls about, and they ran away, and then he said I had robbed him of five guineas and a watch; the watchman told me if I would give him two guineas he would make it up. - Old Bailey Online. Arrived and in 1811 Muster
15. **Elizabeth Faulkner**. Age 20 Tried Q.S. Guildford 2 October 1798 and sentenced to 7 years transportation . ONLY TRANSPORTATION DOCUMENTS but have found some documents which might indicate she survived until 1803 in the colony. Will need to check for other Elizabeth Faulkner's in the colony at the time.

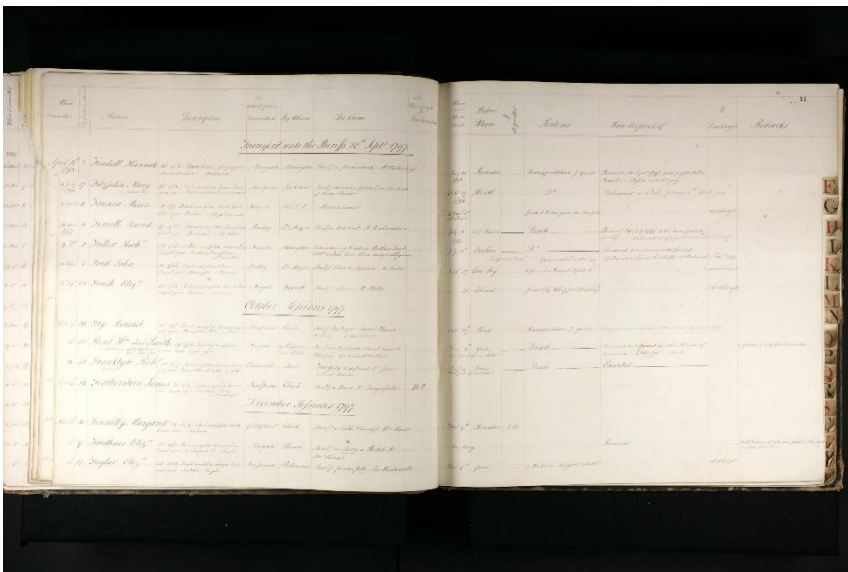


16. **Mary aka Catherine Fitzjohn**. Age 33. Her age here does not concord with the 3 possible dates in court records 1763, 1764 or 1771.

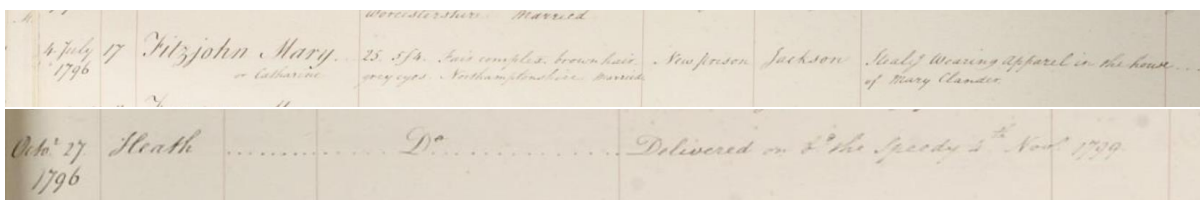

There are confusing dates for two Catherine Fitzjohn's who appear to be the same. One has her born 1771 and one set born 1763/64.

This one Mary aka Catharine FitzJohn who was born 1771 in Northhamptonshire. Tried Middlesex 26 October 1796 and sentenced to 7 years transportation. for feloniously stealing, on the 2d of July , a pair of women's stays, value 6d. a flannel petticoat, value 6d. a black silk cloak, value 6d. a linen gown, value 12d. a check linen apron value 6d. a white linen apron value 4d. a woman's linen shift, value 12d. a pair of worsted stockings, value 2d. three linen caps, value 3s. a pair of silk mitts, value 2s. two yards of silk ribbon, value 12d. and a cotton shawl, value 12d. the property of Mary Clander, widow. Prisoner's defence. My husband brought these things to me, and I have never seen him since; I have been here ever since the sessions before last, and had nothing but what the gentlemen of the jail pleased to give me and my babe, I have no friend in the world. - Old Bailey Online.



The court record left confirms the Mary aka Catherine above is the one who was transported on Speedy



There is a baby John

FitzJohn born to Francis and Mary Fitzjohn on 13th Sept 1795 in Wood Newton Northhamptonshire. This could be the babe referenced in the court hearings. The Mary here is likely to be Mary Russell as there is a marriage certificate between Mary and Francis in WoodNewton on 1/10/1794. Francis was also born in 1771. There appear to be children to this couple up to 1803 so this discounts them.

Mary aka Catherine had been incarcerated in Newgate Prison since 1796 and transferred directly to the Speedy in November 1799. No register of a child accompanying her on board from prison.

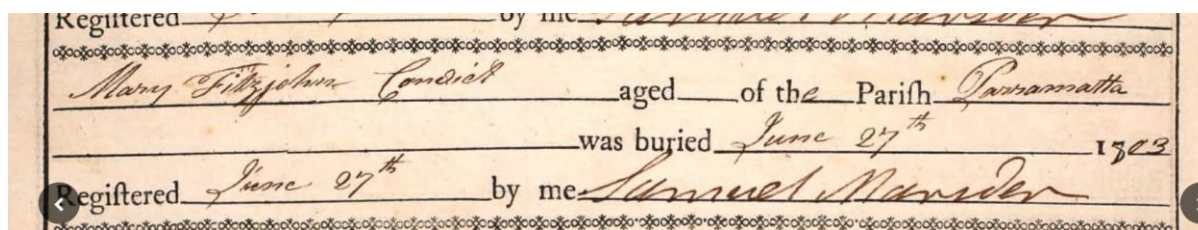

17. **Mary Garnham**. Age 17. Tried London 9 January 1799 and sentenced to transportation for life for feloniously stealing, on the 22d of December, six yards of cotton, value 12s. the property of William Hopps, privately in his shop [Old Bailey Online](#). She married John Brown a London shoemaker who arrived on the Earl Cornwallis in 1800. Mary Brown died by her own hand in 1819. An inquest found she was suffering from a deranged mind at the time. Witness at her inquest included her son John Brown and Mary Underhill. Arrived and in 1811 Muster.
18. **Ann Goodwin**. Age 29. Tried Maidstone 15 July 1799 and sentenced to 7 yrs transportation. This is Amelia Goodwin <https://gw.geneanet.org/coraki?lang=en&iz=36512&p=james&n=rixon&oc=1>. She partnered with James Rixon and had several sons until he died in 1811. She married Robert Burrows and had a final son Robert. She was a landholder in Campbelltown.
19. **Elizabeth Grant**. Age 18. Tried Surry Q.S. 27 February 1798. Arrived in district constables notebook 1822.
20. **Mary Guile**. Age 22. Tried 20 September 1797 in London and sentenced to 7 yrs transportation. Received a Certificate of Freedom in January 1810. Arrived
21. **Hannah Hardcastle**. Age 20. Tried in London 24 October 1798 and sentenced to 7 years transportation. Received a Certificate of Freedom in January 1810 Arrived
22. **Elizabeth Harenaugh**. Age 18. Tried Middlesex 4 July 1798 and sentenced to transportation for life. Surname is Starenaugh. Have document for Elizabeth Stanenhilt arrived on Speedy tried in Old Bailey in July 1798. Found with various spelling of surname in musters and census. Could get mixed up with Elizabeth Statham also who cannot be found after 1800.
23. **Catherine Herbert** Age 26. Tried at Reading 3 March 1798 and sentenced to transportation for life. Arrived and recorded in 1816 census.
24. **Martha Hill**. Age 27. Tried Guildford 30 July 1798 and sentenced to transportation for life, Arrived and is in 1820 census.
25. **Susannah Harrison**. Age 17. Tried Middlesex 8 May 1799 and sentenced to Transportation for life. On list of grants and leases of town allotments in July 1809. Received an absolute pardon in March 1810. Arrived.
26. **Elizabeth Hasten**. Age 19. Tried Maidstone 23 July 1798. Listed as Elizabeth Hastings and is registered in 1816 lists of convicts.
27. **Maria Jennings**. Age 21. Tried 23 May 1798 and sentenced to 7 years transportation. Married Thomas Haines in Parramatta in 1848.

28. **Sarah King**. Age 20. Tried Croydon Summer Assizes 27th July 1799 and sentenced to 7 yrs transportation. (The Summer Assizes are once in two years at Guildford, and the prisoners then kept at the Bridewell there. Every other summer they are held at Croydon, and during the time were confined, heretofore, in stables, which are now properly converted into a large room suitable for the purpose.)...[Gentleman's Magazine. Arrived and registered in 1817 muster](#)
29. **Catherine Lahey**. Age 18. Tried Middlesex 12 September 1798 and sentenced to transportation for life. Catherine Lahey and Ann Warner were indicted for that they, on the 14th of August , a piece of base coin resembling a shilling, falsely, deceitfully and traitorously, did colour, with materials producing the colour of silver. Lahey's defence. I was coming past the New Church in the Strand, and I found a paper parcel; when I came home I opened it, and saw it was money, and when these gentlemen came into the room I was wiping the dirt off; whether it was good or bad I know not. [Old Bailey Online. Arrived- Died in NSW in 1868.](#) Possibly listed in 1818 as Catherine Lee. Multiple census and musters list her as Catherine Lee. 1822 came on Speedy Lifer and is wife of J Mitten and has 5 children born in the colony.
30. **Sarah Lawrence**. Age 19. Tried in London 12 September 1798 and sentenced to 7 years transportation Sarah Lawrence and Mary Smith were indicted for feloniously stealing on the 2d of August , four pair of silk stockings, value 44s. the property of John Garton , in his dwelling-house. [Old Bailey Online. Arrived and recorded in 1820 muster](#)
31. **Elizabeth Lilley**. Age 25. Tried Q.S. Guildford Surry 15 January 1799. and sentenced to 7 s transportation. Arrived and in 1818 muster . Arrived 1817 muster
32. **Mary Miller**. Age 16. Tried Middlesex 19 June 1799 and sentenced to 7 yrs transportation. MARY MILLER , JOHN SHARPLESS , and WILLIAM MANSELL , were indicted for feloniously stealing, on the 12th of June , a leather pocket-book, value 14d. the goods of James Hyne , privily from his person .Arrived in 1819 census.
33. **Jane Patterson**. Age 19. Tried Middlesex 19 April 1798 and sentenced to 7 yrs transportation. Had a child Elizabeth on board with her which became very ill and died on 25th January.
34. **Mary Peake**. Age 19. Tried Surry Q.S. 27 February 1798. Arrived and in 1817 muster
35. **Sarah Seaton** Age 28. Tried Middlesex 18 April 1798 and sentenced to 7 yrs transportation. Arrived and in 1825 muster
36. **Mary Shay**. Age 21. Tried Surry Q.S. 27 February 1798. Arrived and in 1825 muster.
37. **Ann Sidney**. Age 27. Tried Middlesex 12 September 1798 and sentenced to transportation for life
38. **Elizabeth Smith**. Age 27. Tried Middlesex 4 July 1798 and sentenced to 7 yrs transportation. Died in NSW in 1838 aged 66.
39. **Elizabeth Smith**. Age 19. Tried Hertford Assizes 16 July 1798 and sentenced to 7 yrs transportation One of these are in 1820 Population Book not sure which Elizabeth though- free by servitude. Confirmed in 1820 muster / indents.
40. **Ann South al. Archer**. Age 20. Tried Middlesex 12 September 1798 and sentenced to 14 yrs transportation. Arrived and recorded in muster 1820
41. **Elizabeth Statham**. Age 25. Tried in Middlesex 3rd December 1798 and sentenced to 7 yrs transportation for Larceny. ONLY HAS SHIPPING DOCUMENTS. Was tired at Session of Peace Middlesex.. Her Newgate files say she

was admitted on 10/12/1798. At last Anna Kings diary states Elizabeth died Monday 16th. This is a death separate to JHB's mum.

There is also as record of an Elizabeth Statham convicted in 17th Dec 1789 of a felony. Perhaps another Elizabeth. There is another Elizabeth Statham who was convicted at Warwick Assizes and sent here in October 1828 and had pardon in 1835 she is not this Elizabeth Statham. She came on the Competitor.

There is an Elizabeth Statham Matron of the Convict Lunatic Asylum . She took up this position on 1st March 1847 appointed by the Governor. She remains a matron in 1856. Noticeably Edwin Statham is storekeeper at the asylum so it is unlikely this Elizabeth is ours or the other convict woman but the wife of Edwin Statham. This woman was Elizabeth Cox.

42. **Sarah Turner** convicted Middlesex 14th Feb 1798 sentenced to 7 years. On Speedy register. Listed in the 1811 population muster so survived the trip.
43. **Mary Thomas**. Age 43. Tried Middlesex 3 April 1799 and sentenced to 7 yrs transportation. Arrived and in 1816 muster
44. **Sarah Thomas**. Age 15. Tried 19 June 1799 at Middlesex and sentenced to 7 yrs transportation. Arrived and in 1816 convict lists. Also listed in indents 1820
45. **Sarah Thomas** <http://members.iinet.net.au/~perthdps/convicts/confem22.html>; lists a second Sarah Thomas transported on Speedy and she was tried at Old Bailey 24th oct 1798 for larceny and sentenced to transportation, The outcome of the sentence was unknown at OB. Listed as widow in indents in 1820.
46. **Margaret Thompson** Age. 22. Tried in London 18 April 1798 and sentenced to transportation for life for highway robbery. The Old Bailey record of 25/5/ 1798 states that the prisoner has not used pregnancy as reason to appeal the sentence. The Old Bailey records list her as 33 years of age.
47. **Susan Tillett**. Age 20. Tried in Essex 18 July 1798 Susan Tillett. Age 20. Tried in Essex 18 July 1798 and sentenced to transportation for life. Listed in 1816 convict lists,
48. **Mary Underhill**. Age 24. Tried Middlesex 3 April 1799 and sentenced to 7 years transportation....
Mary Underhill and Daniel Fear were indicted, the first, for feloniously stealing, on the 17th of February , a feather-bed, value 20s. a pair of sheets, value 2s. a blanket, value 1s. 6d. a set of fire-irons, value 1s. 6d. a copper tea-kettle, value 2s. an iron saucepan, value 12d. and a pair of bellows, value 12d. the property of Richard Angel , in a lodging-room. Daniel Fear found not guilty. Arrived and in 1816 muster /lists.
49. **Elizabeth Ward**. Age 19. Tried Q.S. Guildford 2 October 1798 and sentenced to 7 yrs transportation. Listed as Elizabeth Hards- sentenced to 7 years came on Speedy. Listed in Castlereagh and Evans population book 1820.
50. **Sarah Whaley**. Age 43. Tried Croydon summer assizes 27 July 1799 and sentenced to transportation for life. Arrived in 1816 lists of convicts
51. **Sarah Willis**. Age 40. Tried Middlesex 12 September 1798 and sentenced to transportation for life. Arrived in 1816 lists of convicts
52. **Sarah Wood**. Age 21. Tried 24 October 1798 and sentenced to 7 yrs transportation. Arrived and in 1820 lists.

53. **Hannah Warburton** listed in NSW Settlers and Convicts List- tried in Maidstone in August 1798. She is definitely Hannah Hardcastle. 1811 muster convicted August 1798 Speedy but in 1814 is listed as coming on Billana and wife of William Hardcastle. She however is listed on the indents of Speedy as Hannah Hardcastle.

Note: 54 and 55 probably Elizabeth Bowmans.

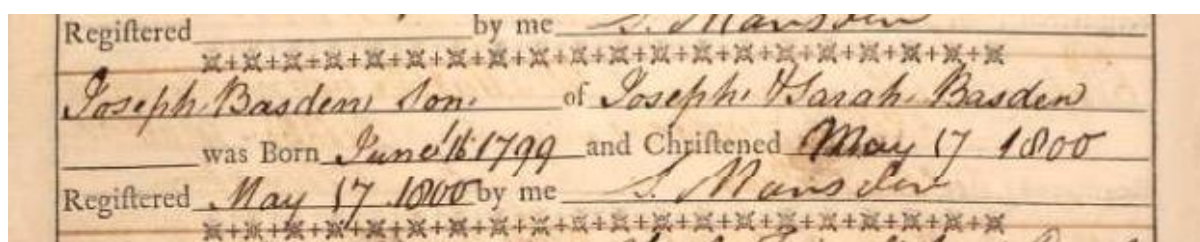
54. Elizabeth Baulsover is listed as convict of Speedy aged 44 in 1828 census

55. Elizabeth O Bower also listed coming on Speedy 1800 in 1828 census sentenced to 7 years and in servitude to Robert Brodie of Liverpool.

56. Hannah Mavily of Speedy indicted in Old Bailey June 1799 and listed in 1820 convict lists as such. There is no record of a Hannah Mavily in Old Bailey only a Hannah Morris who was not transported.

57. Susan Cook or Cock tried in Old Bailey March 1799 in 1820 convict lists in NSW. Susan Cock was sentenced in 15th January 1725 to transportation in Old Bailey. No records in 1799 OB for Susan Cook., Also listed in 1821 convict muster with same information.

58. Abigail Cummings is listed in 1822 list of convicts as coming on Speedy and free by servitude.
